Explanatory Notes – the Town Council portion of the Council Tax bill

St Ives Town Council has set its budget for the financial year 2019/2020 in order to be able to maintain the services it is committed to providing, in the most cost-effective way possible.

Facilities run by the town council include:

St Ives Guildhall and Concert Hall (town council offices and a venue for concerts, plays, functions and weddings)

St Ives Public Library and Information Service (to include the Visitor Information Service from 2019)

The Island Centre (another community building available for classes, functions and events)

The Palemon Best Recreation Ground

The allotments at Trowan

Heritage buildings: St Nicholas Chapel on the Island; St Leonards Chapel at Smeatons Pier; the Baulking House at Hain Walk and the Market House.

Public Conveniences in St Ives and a public convenience at Longstone Cemetery, Carbis Bay

Services provided by the town council include:

Neighbourhood Plan policy setting and review Tourist information Footpath maintenance Street weeding Enforcement of the beach dog control orders Traffic control Civic and Community events

Areas of note in this year's budget are:

- The St Ives Public Library was transferred from Cornwall Council to St Ives Town Council on 29 October 2018. From early 2019, services provided from the library building will increase, with the first change to be the move of the tourist information function to the library, from the Guildhall.
- The budget figures show an increase in the provision for facilities maintenance and management, primarily due to staff costs being transferred from the Services budget to the Facilities budget line.
- In the 2018/19 budget, the revenue budget had included £30,000 allocated to provision of step-free-access to the first floor of the Guildhall, and £10,000 towards a replacement skatepark. Both of these projects have yet to be completed and so the funds will be held until needed. Meanwhile, the budget lines for the Concert Hall and for Palemon Best have reduced as similar amounts have not been budgeted for this year.
- The budget line for the visitor information service has been combined with the Library and Information Service budget as the two services will combine from April 2019.
- Provision has been budgeted towards the cost of maintenance and repairs to a number of councilowned properties.

The net budgeted expenditure is covered by the Precept and the Council Tax Support Grant. In 2019/2020 the Council Tax Support Grant to St Ives Town Council is £18,930.51. The remaining net budgeted expenditure is covered by the precept and so the Precept for 2019/2020 is set at £568,230, which results in a Band D Rate of £109.18 per annum, compared to the 2018/2019 rate of £109.31 per annum.
